## Terms and conditions of the authorization:-

- 1. This authorization is not transferable and the fair price shop holder shall not change the firm in any way or give any general power of attorney to any person for running the fair price shop without prior permission in writing of the deputy Commissioner, Food & Supplies, Delhi.
- 2. This authorization shall be displayed at a permanent place in the fair price shop and shall be produced for inspection when required.
- 3. This authorization is valid only for the premises specified there in and the fair price shop holder shall not store any specified food articles at any other place without prior permission in writing of the authorized officer.
- 4. This authorization is liable to be amended, withdrawn, suspended revoked, rescinded or cancelled in accordance with the provision of the Delhi Specified food articles (regulation of Distribution) Order, 1968.
- 5. The fair price shop holder shall be responsible for carrying out the retail sale of specified food articles efficiently, promptly and in a business like manner and in accordance with the directions and instructions given to him from time to time.
- 6. The Fair Price shop holder shall maintain true and correct account of all purchases and sales of a specified food articles supplied to him from time to time in the prescribed manner and shall be responsible for the safe keeping of all such records and for making them available for inspection as and when required. All such book of accounts shall be kept at the authorized business premises.
- 7. The fair price shop holder display sign board, stock and price board, Notice Board and sealed samples of the food articles in stock at a conspicuous place at his fair price shop.

- 8. The fair price shop holder shall also display at a conspicuous place a complaint book which shall be made available to consumers on demand for the recording of complaints.
- 9. The fair price shop holder shall also maintain an Inspection Book and made the same available on demand by the officers and inspecting staff.
- 10. The fair price shop holder shall also observe the prescribed working hours and lunch interval. The shop shall not be kept closed during working hours without prior permission in writing of an officer not below the rank of Food & Supplies Officer.
- 11. The Fair Price shop holder shall not deal in any articles of the open market which is declared to be specified food article under the Delhi Specified Food Articles (regulation of Distribution) Order, 1968 or install or run any flour mill (Chakki) or run any establishment in which any specified food articles.
- 12. The fair price shop holder shall obtain the specified food articles only in the manner laid down by or under the said order and shall not charge prices higher than the prices fixed by Government for sale of specified food articles.
- 13. The fair price shop holder shall supply specified food articles only a against valid documents issued under the said order and authorized to be registered with him for that purpose.
- 14. The fair price shop holder shall keep permanently closed any door or window which offers access to any other portion of the building in which the fair price shop is situated.
- 15. The fair price shop holder not contravene any of the provisions of the Delhi Specified food articles (regulation of Distribution) Order, 1968, or any other law relating to food stuffs for the time being in force.

- 16. The fair price shop holder extend this full cooperation and assistance to the inspecting staff in the checking of his stocks and accounts and given such information as may be required by them in relation to his business.
- 17. The Fair price shop holder shall comply with any directions or instruction given to him by the authorized officer in regard to the purchases sale and storage of specified food articles and the manner in which accounts them of shall be maintained and returns submitted.
- 18. Whenever the existing issue price of any specified food articled is revised by the government neither upward or downward the stock of specified food articles as on the morning of the day from which the revised issued price comes into force should be assessed and interested to such officers of the Government as may be specifically authorized for the purpose. In the case revision of price upward, differential cost on the quantity of specified food articles so held in stock should be remitted to the Government in the manner specified by the Deputy Commissioner, Food & Supply Delhi, similarly, in the case of revision of price downward, a refund claim for the differential cost should be submitted to such offers of Government as may be specifically authorized for the purpose who will arrange for the necessary refunds.
- 19. Any sum due from the fair price shop holder shall be recoverable as arrange of land revenue.
