NOTICE FOR NON-DEPOSITION OF REPRESENTATION - CUM -DISTRIBUTION OF SFAS FOR THE COST/DRAFT & STOPPING MONTH OF DECEMBER 2013 ONWARD BY THE FPSs. UNDER THE NATIONAL FOOD SECURITY BILL-2013 DUE TO NON FIXATION OF RATE & MODE OF PAYMENT OF COMMISSION/MARGIN MONFY PAYABLE TO FPSs.

RESPECTED SIR,

OUR SUPPORT TO NATIONAL FOOD SECURITY SCHEME-2013

We the undersigned FPS License holders express their strong support to the GONCT's efforts for the implementation of the NFS Scheme even before it could be promulgated as an NFS, ACT, 2013 upon passage by the Lok Sabha and the Rajya Sabha in Delhi w.e.f. 20th August, 2013. It is now a matter of great pleasure that both the Houses of the Parliament have since passed the said NFS Bill 2013 and very soon it vill be transformed into an Act applicable all over the country extending the benefit of 'right to food' to over 80 crore Indian population in Rural & Urban areas at highly subsidised rates.

The Bill passed by the both the houses assented by the Hon'ble President of India on 9th Septemoer 2013, the ordinance has now become the N.F.S. Act 2013 is yet another unique

feature of National Food Policy of India.

IMPLEMENTATION OF NFS SCHEME IN DELHI

You are aware that F.P.Ss are an integral part of the P.D.S. Whereas w.e.f Ist September 2013 in Delhi, this NFS Scheme has already been introduced in a full fledged manner with great pomp and show and with totally revised monthly allocations of SFAs, especially Wheat and Rice for distribution amongst the beneficiaries as envisaged under the NFS Bill-2013 w.r.t quantities of Wheat & Rice and rates for the "priority households" (BPL/APL-JRC and APL-RCRC) and the AAY category of households. (REFER ANNEXURE NO. I).

Since Sh. B.R. Singh special commissioner of the Department of F&S on 8th August 201? during the training / conference in Sai Auditorium had in reply to question raised by the FPSs assured that the commission/margin money enhancement will be done soon, all the FPSs in view of oral promise and assurance extended their cooperation by the depositing the draft meant for September 2013 allocations further keeping into consideration the interests of the 8/10/2013 A.l.

poor consumers/public interest.

That extending full cooperation, all the FPS Licensees without any demur or objections deposited the cost of the monthly allocations meant for September-2013/October-2013 in time and even began the activities pertaining to Distribution there-of w.e.f. Ist September 2013.

OUR PAIN

- There appears conspicuously the deaf and dumb attitude of the Department of F & S towards the remuneration payable to the F.P.Ss. The rewards payable to the F.P.Ss for their services there has been 'NO' repeat 'NO' official word available so far as to how much rate of commission or margin money would be payable to us- whether at old prevailing rates or in the same manner as in the past whatsoever.
- 4. Sir, You are well aware the Commission or Margin money at which all the FPSs have all along been undertaking the issue operations was fixed more than Sixteen Years back on 13th May, 1997 at Rs. 35/- P.Qtl. on weight basis for the quantities issued, effective from 1st June, 1997 (Copy of your INSTRUCTION NO. 18 enclosed for ready reference as ANNEXURE NO. II). Meanwhile over the last one & a half decade much water has flown down the drain due to yearly inflation resulting into totally un-viable operations to sustain our livelihood and now question of our survival have arisen with the NFS Scheme 2013.

WADHWA COMMISSION

- 5. Sir, Justice D.P.Wadhv a Commission has already commented adversely about the Economic Viability of running any F.P.S. and recommended, inter-alia, appropriate-ideal increase in the commission so that the leakages or diversions of subsidised food grains could be plugged, by those elements who indulge into the same due to **compulsions** of the impugned sponsored scheme with many pitfalls.
- 6. Sir, we have also learnt from reliable sources that even the Standing Committee of the Parliament on Food has recommended to the Govt. of NCT of Delhi for appropriate raise in the commission about two-three years back but all in vain, since no action in this connection taken by the Department.

FLAT VERSUS PER PERSON BASIS OF ALLOCATIONS

7. Sir, You are aware with the revised scales of entitlement of SFAs especially Wheat & Rice of the "priority household" category of beneficiaries namely BPL/APL-JRC/APL-RCRC on per person basis has on an average reduced the allocation quantities by about 10Kg. of Wheat & Rice per ration card/per month for each category mentioned above (Wheat by 1/4th and Rice by ½ of the previous 'flat' basis system of allocations/entitlements.) Consequently our sales Quantity would further go down resulting into further reduced commission/margin money or earning every month. This is going to hit each FPS licensee below the belt every month totally making viability of any FPS adversely affected.

PURCHASE PRICE EQUALS SALE PRICE

8. Further prior to 1st September, 2013 all the FPSs were eligible and getting the benefit of commission/margin money just upon the sales of Wheat and Rice to the beneficiaries of BPL/APL-JRC/ APL-RCRC, whereas with the new scheme all the FPSs shall be issuing the SFAs (Wheat/Rice) at the same rates at which these will be purchased i.e, Rs. 2/- per Kg Wheat and Rs. 3/- per Kg Rice that means both purchase and sale rates would be at par.

OUR PLIGHT

9. That in our opinion, it appears that the commission/margin money for the newly introduced NFS Scheme shall be paid by the Department of F & S after sales of Wheat & Rice like those beneficiaries of AAY category card holders as in the past. In absence of any official



announcement or declarations about the rate and mode of payment, we apprehend that it will remain pending for years as in the past in case of sales of wheat & rice for AAY categories.

FOOD DEPARTMENT ACT ONLY ON LEGAL THREATS

- 10. You are also aware that the Department of F & S has released the margin money that was outstanding since September, 2009 upto November, 2011, after April, 2013 that is only after a "Legal Notice" had been served upon the Department in December, 2012.by some well wisher of our fraternity. Even then till date there is no word available from the Department for releasing the yet pending margin money for the last 21 (twenty one) months since December, 2011 to August, 2013. Surprisingly as per your Department's SANCTION ORDER NO. f.13(22)/CFS/AAY/claim/2011-12/pt.file/627 Dated 22/03/02013, (copy enclosed for your ready reference as ANNEXURE NO. III) there have been omissions about release of long old outstanding legitimate dues of margin money pertaining to the Central District and South Districts for which 'NO' order/sanction has been given till date. Above all in respect of one FPS No. 6520 of M/s Agarwal Provision Store functioning under Circle 17(North Zone) also has not been given any margin money of Sept. 2009 onwards till date. Who is answerable for such lapses?
- 11. Sir, Under the scenario cited in the previous para all the FPSs shall have to not only wait for sanction/release of margin money for AAY category sales but also for sales to "priority house hold" card holders now onwards BPL/APL-JRC/APL-RCRC even for reduced quantities of sales.

USING FPS HOLDERS AS BAGAR LABOUR AT THEIR OWN EXPENSE

12. How do you expect all the FPSs of Delhi to undertake issue operations for PDS/TPDS as "BAGAR" Labour and make the Central Government's NFS Scheme successful? This is an unfair policy and unconstitutional approach. You will appreciate & realise, if any government employee is Not paid wages or salaries for one or two months, there can be chaos all around, that for the legitimate dues of FPSs towards margin money /Commission for non-responsiveness will only force some elements amongst the FPSs to resort to diversions/leakages of food grains, because of the un-avoidable expenses they will not be able to avoid & pay from their own pockets e.g., Warner Charges/BAKSHISH/Nashta Charges of Rs.5/- to Rs. 10/-P.Qtl. to the labourers of Transport Contractors of DSCSC Ltd. for unloading of SFAs at the door-step of FPSs. In addition wherefrom they can compensate themselves for the operational/handling shortages of Wheat, Rice & Sugar? They are also to bear every year charges towards stamping of Weights & Measures payable to Metrological Department. Each FPS has also to bear the stationery expenses for printing the Cash Memos, Sales-Stock Register etc apart from Bank Draft charges for the cost of SFAs to be deposited with AXIS BANK. All such charges only increase every now and then.

MANDATORY MINIMUM WAGES

13. Sir, You are aware about the Minimum Wages payable to un-skilled labour in Delhi is mandatorily payable @ Rs. 7,722/-* is p.m per person as per Delhi Govt's Labour Department. Every FPS has to bear this minimum wages payable to weighment/handling boyengaged by the FPS Licensee. Refer ANNEXURE NO. IV enclosed.(*since revised to Rs 8086/- with effect from 1st Oct 2013)

RENTAL VALUE OF FPS PREMISES ETC

- 14. Sir, you know it well that in Delhi the rates of properties have gone up manifold over the last one and half decade since May 1997, when the Department fixed the rates of margin money. Like-wise the 'rentals' of any FPS premises have gone up. As per the norms of the Department for size of a FPS Viz 5M//Lx 3M/Bx3M/H, in any part of Delhi, the rental charges payable will not be less than Rs. 10,000/- (Ten thousand) P.M. Additional expenses towards electricity/power/water/ tea etc have also to be borne by the FPSs. There are other unofficial expenses universally termed as 'SEWA-SHULK' for the Transport Contractor (T.C.) of DSCSC Ltd/anti social elements of Different Departments of GONCT/Police of Delhi etc. which fall upon the FPSs for which there is No limit of amount and No evidence one can produce, but admittedly these are there.
- That the Department of F & S have unilaterally doubled the Security Deposit of Rs. 5000/- to Rs. 10,000/- for FPS License during 2011. It was revised in February, 2004 to Rs. 5000/- and was Rs. 500/- since inception. In addition every FPS has to incur Rs. 500/- towards renewal of License Fees every third year. Even amongst the conditions of issuing FPS License every FPS has to show Rs. 50,000/- as Capital balance in Bank Account.

SAMPLE OF SFAs

16. Incidentally Department of F&S expect every FPS to display conspicuously 'SAMPLE' of Wheat, Rice and Sugar for the benefit of card holders. On 01.08.2013 and on 01.09.2013 SMS flashed by the Department of F&S through TD-DE_FAST to all the FPSs on their mobile phones read as under:-

"Please keep a sample of Wheat/Rice/Sugar for inspection by consumers."

But in reality the DSCSC Ltd never bothers to collect SAMPLE of Wheat and Rice as a routine practice from the FCI. Sporadically upon complaints by some FPSs Sample of Wheat and Rice are collected / supplied by DSCSC Ltd. Sample of sugar has never been supplied by the DSCSC Ltd. even though [SUGAR] it is supplied from its own two godowns of Gazipur and Siraspur. This point was also raised on 8th August 2013 by all the FPSs in the special Training organised by the Department of F&S at Satya Sai Auditorium, Lodi Road, New Delhi, in the presence of Special Secy-cum-Special Commissioner, Sh. B.R.Singh and the Zonal Officers but all in vain.

PRESENT MAXIMUM MONTHLY EARNINGS OF FPS (w.r.t Allocations of SFAs of October, 2013 of 44 FPSs in Circle No. 17 which is the highest allocation circle in North Zone) 17. Interestingly the NFS Scheme 2013 envisaged and commenced in Delhi w.e.f 1st September, 2013 shall enable on an average a MAXIMUM monthly earning of Rs. 6100/-(Rupees Six thousands one hundred only) at the prevailing rate of commission/margin money of Rs. 35/- P.Q.of SFAs issued. This is demonstrated below ,as an example, for your ready perusal.

Rs. 267940 ÷ 44 FPS = 6090/-PM or say Rs. 6100/-P.M. (REFER ANNEXURE' NO. V & VI FOR FPS-WISE ALLOCATION OF WHEAT & RICE)

That on an average each FPS will have a Maximum earning p.m of Rs. 6100/- assuming every FPS has equal number of Ration-cards and quantities. Even out of this the instant earnings w.r.t APL-stamped quantities shall be just Rs. 800/-PM on an average and balance Rs. 5300/- pm. shall be paid/payable in due course by the Department of F&S at its own sweet will. It thus clearly implies that the Department expects FPS to manage his livelihood of family with just Rs. 800/- PM and also simultaneously pay out of his pocket towards various other expenses narrated aforesaid.

Big Basic question thus arises as to :-Q.HOW WOULD IT BE POSSIBLE FOR ANY FPS FOR THAT MATTER TO SUSTAIN AND SURVIVE?

OUR SUGGESTION FOR ENHANCEMENT IN RATE OF COMMISSION/MARGIN MONEY PAYABLE TO FPS

Any class IV employee of the Government gets about Rs. 20,000/- (Rupees Twenty Thousand) every month as wages with lot of other benefits of LTC, Medical, CPF, LEAVE ENCASHMENT etc. If the GONCT genuinely expects and endeavors to make DELHI PDS as a model for the country in implementation of NFS Act 2013, the increase in the rate of commission/margin money has to be hiked or increased at least EIGHT TIMES of the prevailing rate of Rs. 35/-PQ or to Rs. 280/-PQ. Then only average monthly earning would be Rs. 48,800/-P.M. i.e. slightly better than class IV employee, of Rs28,800/- after adjusting the expense of any FPS of Rs. 20,000/- P.M. Approx at least.

OPERATIONAL PROBLEMS & CONSEQUENTIAL LOSSES/COSTS TO BE BORNE BY THE FPSs WITH NO ACTION BY THE DSCSCLTD

19. On many occasions there are shortages in supply of SFAs at the time of receipt by the FPS premises through the T.C.'s of the DSCSC Ltd. Claims for such shortages are to be lodged by the FPS Licensee with the DSCSC Ltd and pursue and await refunds, which is seen as a time consuming exercise/drill. Remedial actions are, however, not taken in time by the DSCSC Ltd for preventing such instances in future due to complacency. Computerized weighment slips & "sample" of Wheat & Rice of FCI for each vehicle, despite demand are not supplied alongwith the release order "RO" as routine practice. Whereas FPS Licensees are always under threats of suspension of license or FIR, if any, variations in physical stocks in the shops exceeding 50 Kg or one Quintal is observed upon inspections. Hidden losses and costs due to such factors are there and are to be faced by each FPS practically. Surprisingally 'No' FIR is lodged against the Transport Contractor of the DSCSC Ltd. and no serious action taken against the Incharge of DSCSC Ltd. even for the repeated occurrences of short supplies at FPS door steps. Why?

OUR DEMAND AND NOTICE

20. Above description is made about various expenses each FPS has to incur which obviously should be out of the return in the form of commission/margin money any FPS has to earn for rendering his/her services. But the plight of poor FPS Licensees is such that they are to not only bear the unjust criticism of public or blame from cardholders but also suffer financially. There is none to consider about the financial hardships faced by the FPSs. That is the reason, we have unanimously decided to file this representation-cum- Notice for your immediately deciding the Rate of Commission/ margin money and the mode of payment, if the services of FPSs are to be availed from December -2013 onwards. We are also bringing to your

kind notice and attention that we the undersigned FPS applicants will be restrained and therefore shall not deposit the Cost of SFAs of December-2013 allocations until & unless the Department gives written assurance <u>IMMEDIATELY</u> about remunerative scale of Commission/Margin money.

PRAYER

21. We humbly pray your Honour to immediately enhance the rate of Commission/Margin Money and fix time limit within which it will be payable along with mode of payment preferably E.C.S. followed with details of Quantities considered, commodity-wise & category wise, monthwise.

Govt. of India has increased the central issue price of wheat and rice w.e.f. 1.6.97 and have further authorised the State Govt. to fix the price at FPS level. In visw of this, Govt. of NCT of Delhi has after considering the requests from the Delhi State Civil Supplies Corporation and the Fair Price Shop Associations, revised the transportation charges and handling charges payable to D.S.C.S.C. and the margin of profit of the Fair Price Shop holders.

The revised prices of wheat and rice effective from 1.6.97 are as under:-

Central Issue Price for

Retail price for Card Holders.

FPS holders

Rs. 450/- per quintal

Rs. 5.00 par kg.

Superfine

Rice.

Rs. 750/- per quintal

Rs. 8.00 per kg.

3. The transportation charges and handling charges payable to D.S.C.S.C. and margin of profit of the FPS holders have been uniformly fixed for wheat and rice as under:-

Handling & transporation

Rs, 15.00 per quintal

Margine of profit of Fair

Rs. 35.00 per quintal

Higher increase in the margin of profit for wheat will automatically take care of the lower margin of profit for rice.

- 4. The drafts for wheat and rice for the 1st fortnight of June 97 and onwards will be prepared at the above central issue prices.
- 5. Unlifted stock of wheat and rice from the godowns of FCI as on 1.06.97 will be released by the FCI after taking additional drafts for the difference in the price which are Rs.48/- per quintal in respect of wheat and Rs. 102/- in respect of superfine rice.
- 6. If excess quantity of wheat is received in June against the May quota it will beadjusted in the month of June by reducing the equivalent quantity of wheat by the circle office at the time of next allocation.
