Subject:- Suggestive measures as per the DSRDS to contain & control

inflationary tendencies in food grains in Delhi/NCR and how the present Delhi Government has been adopting anti-inflationary policy pertaining to food grains distribution in Delhi against the desire of the Central Government to curb inflation in food articles and making entire fraternity of F.P.Ss suffer in Delhi.

Reference:- Our pending letter of even No.DSRDS/2014/18 Dated 24th June,2014 with yourself, containing details of our various grievances to be resolved by GONCT of Delhi and the Department of CAF & PD.G.O.I

Sir,

We are pained to bring to your kind notice that how the present government of Delhi has been responsible and working much against the serious attempts of the Central Government under the Dynamic Leadership of Hon'ble Shri Narendra Modi, our Prime Minister and his team to curb and control the inflationary tendencies in food articles across the country and particularly in Delhi. The officer responsible is none but

Shri S.S.Yadav, I.A.S presently working as Principal Secretary-cum-Commissioner, Food & Supplies, [CF&S] GONCT of Delhi with additional charge of the Delhi State Civil Supplies Corporation Ltd [DSCSC Ltd] as a Chairman-cum-Managing Director [CMD] an organization which is an integral part in operation of public distribution system [PDS] for arranging smooth supplies of food grains in entire Delhi up to the door steps of the Fair Price Shops [F.P.Ss] after lifting from the godowns of the Food Corporation of India [FCI] located within Delhi.

There has been a total failure of both the Department of F & S, GONCT of Delhi and DSCSC Ltd both headed by Shri S.S Yadav. For details our previous reference cited above is relevant in this regards, therefore, for the sake of brevity contents therein are not repeated or reproduced here again. The only additional grievances of the DSRDS remains are [i] that despite the assurance and promise by the C[F&S] the transportation charges incurred by each of the F.P.S. for transportation of wheat and rice from the depots/godowns of the FCI for the quantities lifted in the month of June, 2014 by extending cooperation as a special gesture on the request of the C[F&S] on 13 June, 2014, are still not reimbursed even though it were to be adjusted against the advance cost of S.F.As for the month of July, 2014. Unfortunately there is no word available from the Department as to when these will be now reimbursed or refunded. Irony is each F.P.S had already deposited the cost of S.F.As along with transportation charges [cartage] for the month of June, 2014, in advance up to 26th May, 2014, the last date of depositing the cost of S.F.As prescribed by the C[F&S]. Even there are no directions for adjustment or refund, though the cost of S.F.As for the month of August, 2014 have become payable by 4th August, 2014. We have even requested in this regards several times to the C[F&S]/C.M.D [DSCSC Ltd] but all in vain. [ii] The margin money payable to the F.P.Ss @ Rs35/- P.Q. was fixed 17 years ago in May, 1997 for wheat and rice. G.O.I, through its Department of CAF & PD [Department of P.D] has to advise the about the manner and norm to the GONCT of Delhi to enable the Delhi Govt consider fixation of our margin money at revised level. Decision on this issue has to be expedited by your kind intervention. We are also suffering because **NO MARGIN MONEY IS PAID TO ANY FPSs IN DELHI SINCE APRIL, 2014 BY DELHI GOVT.** till date.

DSCSC Ltd has also failed to organize supplies of wheat, rice and sugar in time since April, 2014 because every month extension is sought from the FCI/GOI resulting into the sufferings of both the consumers and F.P.Ss. The dependent poor beneficiaries/consumers-ration card holders had to not only waste time in making enquires by frequent visits to F.P.Ss but also in getting their ration of each month in next month, postponing hunger to next month.

As regards the anti-inflationary activities of the Department of F&S, GONCT Delhi against which we are suggesting remedial action or measure, your Honor will appreciate the factual position highlighted below with supporting data.

The plight of PDS in Delhi can be gauged from the fact that the regular monthly allocation of both wheat and rice as per allocations given by the Central

Government are even not utilized in full at all. Thus Department of F & S, GONCT seems clearly not at inclined to raise the availability of wheat & rice in Delhi, which alone could keep the upward trend in prices of food grains in check and control. The following numerical data would further substantiate the fact that the even allocated quantities are allowed to lapse every month in Delhi due to faulty policy adopted.

Subject: Serious grievances of the 'Delhi Sarkari Ration Dealers Sangh (Fair Price Shopkeepers of Delhi)'.

Sir,

I am enclosing herewith a copy of the letter no. DSRDS/2014/21 dated 4th August, 2014 enclosing therewith previous reference dated 24th June, 2014 also addressed to the Hon'ble Minister of Food, GOI. On perusal of both these references you will appreciate that there has been a total failure on the part of the GONCT of Delhi and especially the Department of F & S.

Their grievances inter-alia relates:

1. Non fixation/revision of margin money payable to the FPSs since May 1997.
2. Non-payment of margin money since April, 2014 till date.
3. Non-reimbursement/refund of Transportation charges incurred by FPSs during June, 2014 despite assurance by the Commissioner (F&S).
4. Moreover, the monthly allocation of Wheat and Rice given by the Central Government in favor of Delhi is not utilized in full therefore these are allowed to lapse in substantial quantities. Just to site the quantum of monthly lapsation has been wheat-11,769 MT and rice-5079 MT in other than NFSA scheme during August, 2014.
5. Superficial claim of weeding out of ration cards has not been done fairly because Commissioner (F&S) continuous insistence of Adhar Card/NPR despite orders of the Hon'ble Supreme Court of India & Division Bench of Hon'ble High Court of Delhi at New Delhi to the contrary.


