Sir,

First of all we/I would like to draw your kind attention that we/I have already approached your good self on 03-10-2013 & your office has responded vide reference cited above. Therefore you are requested to link the relevant papers at your end. However copy enclosed for ready reference as ANNEXURE I & II

2. That Model Code of Conduct in Delhi was over on 4<sup>th</sup> December, 2013 the date when elections for Delhi Assembly was concluded.

3. That it is true & we are honestly & cordially saying that the scheme of National Food Security was introduced in entire Delhi through the shopkeepers [FPSs] in Talkatora Garden stadium w.e.f. from 20-08-2013 by the then Honorable Chief Minister of Delhi in the presence of all the concerned functionaries of the Department of Food & Supplies amongst others treating them an integral part of the scheme.

4. That you had got the aforesaid scheme announced and even on 08-08-2013 in the SAI, Auditorium, New Delhi during the Training organized by the Department of F&S for all the FPSs of

Delhi circulated printed leaflet which is annexed with the joint representation filed by on 03-10-2013. That this leaflet clearly showed that not an iota of margin money was decided or declared except paise 10 per kg for sugar only & all FPS holders had raised their voice amongst suggestions sought by your officers. The only redeeming feature was an assurance declared orally by Shri B.R. Singh, Special Commissioner that action on suitable level fixation or revision of margin money/commission will be done very soon.

5. That in Delhi only on your efforts the NFS was launched w.e.f. 1<sup>st</sup> September, 2013 even though NFS Bill / Ordinance was still to be passed by the Lok Sabha or Rajya Sabha. That the NFSS could become operative in Delhi because of the verbal assurances of your senior officers & all the FPSs of Delhi very sincerely and whole heartedly volunteered to cooperate the department for making it a successful venture & started undertaking the distribution work of PDS w.e.f. 1<sup>st</sup> September, 2013. Nevertheless until 03-10-2013 "NO" word whatsoever was communicated either in writing or announced orally when within two months time itself all the FPSs had started realizing the pinch, and virtually served joint representation-cum-notice for non deposition of cost/draft & stopping of distribution of SFAs for the month of December, 2013 onwards due to non fixation of rate of margin money/commission & its mode of payment.

6. That due to non fixation of rate of margin money etc by the department the financial condition of every FPS has started suffering adversely as unavoidable expenses in running the shops keep hitting them left & right, consequently their capital base kept depleting day by day making their livelihood too extremely difficult.

7. That on receipt of reply from Shri Ravi Dadhich, Addl. Commissioner, F&S, Distribution dated 25-10-2013 that matter regarding upward revision of commission/margin money of FPS authorization holder is under active consideration of this department and no sooner model code of conduct is over it shall be processed for consideration & approval of competent authority. Even after patient hearing of the delegation Shri Dadhich in person addressed sympathetically in the conference room of the department to a large number of FPS holders present about the justification for raising the margin money/ commission. That again we all were feeling great consolation due to his assurance followed by his formal communication aforesaid.

8. That as there is no mention about the margin money/commission rate for the FPSs in the N.F.S. Act, 2013 as well as in any Gazette notifications of your department as yet as to who and when & at what rate it will pay and what will be

the modus operandi of releasing the same to the FPSs, we have again started feeling panicky.

9. That constitutionally when the business of PDS has commenced afresh under the new N.F.S.Act,2013 which is notified through Gazette of India No20 of 2013 on 10-09-2013,about the margin money etc the Central Government has to prescribe about the margin money, transportation charges, as we note & quote below:-

Quote:-under Article 22,Chapter VIII(4)(d)which says "provide assistance to the state government in meeting the expenditure incurred by it towards intra-state movement, handling of food grains & margin money paid to the fair price shop dealers in accordance with such norms & manner as may be prescribed by the Central Government." Unquote

10. That by virtue of aforementioned proviso in the N.F.S.Act,2013 how the Addl. Commissioner, F&S, Distribution advised us on 25-10-2013 about the upward revision of the commission/margin money of FPS authorization holders is under active consideration of this department as we understand the Central Government has yet to prescribe as aforesaid under the N.F.S.Act,2013.We therefore apprehend that in absence of any Minimum level of margin money/commission neither disclosed /prescribed by neither the Central Government nor the GONCT of Delhi as a

benchmark ,basic and fundamental question arises about upward revision itself as assured by your department? Therefore the alleged assurance for upwards revision of commission/margin money to us appears nothing but a “LOLLYPOP”.

11. That it is also emerging abundantly from above how and why the services of all the FPSs are being availed? This is unconstitutional under Article 23 of the Constitution of India, just like “BEGAR “Labour. This is not permissible and infringes this constitutional provisions and is an offense punishable in accordance with law. Refer Annexure III

12. That already four months have elapsed and 5<sup>th</sup> month is running since 1<sup>st</sup> September,2013 when onwards all the FPSs of Delhi have been working without any reward or compensation or wages or margin money or commission for undertaking distribution of food grains to all the beneficiaries, surprisingly at lower than the previous monthly allocations, under the new N.F.S.Act,2013.Consequently majority of the FPSs of Delhi have expressed their serious grievance about erosion of their capital base and are at the verge of collapsation/ insolvency.All this is because of non realization by the concerned authorities about a very vital & sensitive issue of the economic viability of the FPSs already adversely commented upon by the Wadhwa Commission.

13. That due to rental of the premises, labour cost of the weightment man, [minimum statutory fixed wage payable under the law], stationery expenses, bank charges for draft including interest on capital, electricity expenses, shortages/wastages & other hidden unforeseen expenses apart from living hood expenses etc it would not be feasible & possible to stretch any further our operations. You will kindly appreciate that at any time any of the FPS can be a victim of insolvency.

That in view of the aforesaid factors and genuine plight of the FPSs going on, the only alternative left with us is either to close or choose the appropriate legal forum for redressal for securing our business as well as public interest.

## राष्ट्रीय खाद्य सुरक्षा कानून 1.9.2013 से दिल्ली में लागू

1. दिल्ली में 73 लाख लोगों को खाद्य सुरक्षा मिलेगी।
2. वर्तमान ए.ए.वाई. / बी.पी.एल. / जे.आर.सी. / आर.सी.आर.सी. कार्ड धारकों को खाद्य सुरक्षा में शामिल कर लिया गया है। ऐसे परिवार नया राशन कार्ड पाने के लिए राशन दफ्तर या जीआरसी में उपलब्ध प्रपत्र में अपनी जानकारी का नवीनीकरण करवाएँ। नया राशन कार्ड बनने तक वर्तमान राशन कार्ड से ही खाद्य सुरक्षा का लाभ पा सकते हैं।
3. जिन परिवारों के पास कोई राशन कार्ड नहीं है या ए.पी.एल. या ए.पी.एल. स्टैम्पड कार्ड है वह भी नया राशन कार्ड बनवा सकते हैं।
4. जिन ए.पी.एल. स्टैम्पड परिवारों को राशन मिल रहा है, उन्हें नया राशन कार्ड बनने तक वर्तमान दर और मात्रा में राशन मिलता रहेगा।
5. राष्ट्रीय खाद्य सुरक्षा कानून के तहत दिल्ली में निम्नलिखित श्रेणी के लोग पात्र हैं :-
  - (i) स्लम निवासी
  - (ii) F, G एवं H श्रेणी के पुनर्वास कालोनी के निवासी
  - (iii) ग्रामीण क्षेत्र के अधिसूचित आबादी क्षेत्र में रहने वाले लोग।
  - (iv) बेघर व्यक्ति
  - (v) किन्नर
  - (vi) निःशक्त व्यक्ति (समान अवसर, अधिकार संरक्षण और पूर्ण भागीदारी) अधिनियम 1995 के अन्तर्गत निःशक्तता का प्रमाणपत्र प्रस्तुत करने वाले विकलांग व्यक्ति।
  - (vii) एकल महिलाएँ (घर में किसी दूसरे पर निर्भर रहने वाली महिला), जिसमें विधवा, कुँआरी, तलाकशुदा एवं परित्यक्त महिलाएं शामिल हैं।
  - (viii) बेसहारा बच्चे।
  - (viii) पेशागत निर्बल समूह जिसमें कूड़ा बिनने वाले, भवन निर्माण में लगे अकुशल मजदूर, कुली, दिहाड़ी मजदूर, अनियमित घरेलू कर्मचारी, साईकिल रिक्शा चालक, लघु उद्योग एवं कुटीर उद्योगों में लगे अकुशल मजदूर शामिल हैं।
  - (ix) अन्य परिवार जिनकी पारिवारिक वार्षिक आय रु. 1 लाख या उससे कम है।
6. निम्नलिखित श्रेणी के लोग खाद्य सुरक्षा के पात्र नहीं हैं:-
  - (i) यदि परिवार के किसी सदस्य के पास हल्का या भारी चार पहिया वाहन है (यदि जीविकोपार्जन के लिए एक व्यावसायिक वाहन है तो उसे अयोग्य नहीं माना जाएगा)

## मुख्य विशेषताएं

- ग्रामीण क्षेत्र के 75 प्रतिशत एवं शहरी क्षेत्र के 50 प्रतिशत लोगों को जन वितरण प्रणाली के तहत सामान्य श्रेणी के परिवार को 5 किग्रा/सदस्य के अनुपात में अनाज, प्रत्येक महिने मिलेगा।
- वर्तमान ए.ए.वाई श्रेणी के परिवार को 35 किग्रा अनाज प्रति कार्ड प्रत्येक महिने मिलेगा।
- सब्सिडाइज्ड मूल्य क्रमशः 2 एवं 3 रुपए/ किग्रा की दर से गेहूँ और चावल दिया जाएगा।
- दिल्ली में 73 लाख लोगों को इसका लाभ मिलेगा। प्रथम चरण में 32.39 लाख ए.ए.वाई/बी.पी.एल./जे.आर.सी./आर.सी.आर.सी. कार्डधारियों को इसका लाभ मिलेगा।
- परिवार की वरिष्ठ महिला के नाम पर, जिसकी उम्र 18 वर्ष से कम न हो, इस योजना का लाभ उठाने हेतु राशन कार्ड बनाया जाएगा।

## उचित दर दुकानदारों का कार्य

- फार्म का वितरण
- आवेदनकर्ताओं के लिए फार्म भरने में सहायता करना तथा फार्म भरने हेतु आवश्यक दस्तावेजों का प्रबंध करवाना।
- आवेदको को भरे हुए फार्म जी.आर.सी. या मंडल कार्यालय में जमा कराने के लिए बताना।

## संशोधित वितरण योजना

- ए.ए.वाई. श्रेणी के लिए आवंटन में कोई बदलाव नहीं किया गया है।
- पहले की ही तरह 2 रुपए/ किग्रा की दर पर गेहूँ और 3 रुपया/ किग्रा की दर पर चावल क्रमशः 25 और 10 किग्रा दिया जाएगा।

## बी.पी.एल./जे.आर.सी./आर.सी.आर.सी. श्रेणी के लिए-

- प्रत्येक व्यक्ति को 5 किग्रा राशन (4 किग्रा गेहूँ और 1 किग्रा चावल) मिलेगा।
- अर्थात् 5 सदस्य वाले परिवार को कुल 25 किग्रा अनाज (20 किग्रा गेहूँ और 5 किग्रा चावल) मिलेगा।
- गेहूँ 2 रुपया/किग्रा और 3 रुपया/ किग्रा की दर से मिलेगा।

- (ii) यदि परिवार के सदस्य के पास दिल्ली में A से E श्रेणी का कोई मकान या जमीन है।
  - (iii) यदि परिवार का कोई भी सदस्य सरकार से किसी भी योजना के अन्तर्गत राशन या खाद्य सब्सिडी प्राप्त कर रहा है।
  - (iv) यदि परिवार का कोई सदस्य आयकर दाता है।
  - (v) यदि परिवार का कोई सदस्य केन्द्र / राज्य / स्थानीय निकाय / केन्द्र या राज्य की स्वायत्त संस्थाओं इत्यादि में किसी भी पद पर कार्यरत है।
  - (vi) यदि परिवार में बिजली का कनेक्शन 2 किलोवाट से ज्यादा का है।
7. नया राशन कार्ड बनवाने के लिए राशन दफ्तर अथवा जी.आर.सी. में उपलब्ध फार्म भरकर जमा करवाएं। फार्म के साथ निम्नलिखित दस्तावेज संलग्न करें :-
- (i) परिवार के सभी सदस्यों के आधार कार्ड/EID की कापी।
  - (ii) आवेदक के निवास प्रमाण पत्र की कापी यदि आवेदन में दिया हुआ पता, आधार कार्ड में दिए हुए पते या राशन कार्ड के पते से भिन्न है। बेघर व्यक्ति के लिए निवास प्रमाण पत्र की आवश्यकता नहीं है।
  - (iii) राजस्व विभाग द्वारा जारी किया हुआ आयप्रमाण पत्र, जहाँ आवश्यक हो। (केवल निर्देश संख्या 5 के क्रम संख्या (ix) में ही आय प्रमाण पत्र आवश्यक है।)
8. राष्ट्रीय खाद्य सुरक्षा कार्ड परिवार की वरिष्ठतम महिला के नाम से बनेगा। यदि परिवार में 18 वर्ष या उससे अधिक आयु की महिला नहीं है तो परिवार के पुरुष सदस्य के नाम से राशन कार्ड बन सकता है।
9. खाद्य सुरक्षा कानून के तहत गेहूँ 2 रू. प्रति किलो और चावल 3 रू. प्रति किलो की दर से दिया जाएगा।
10. खाद्य सुरक्षा कानून के तहत पात्र परिवार एएवाई व प्राथमिकता श्रेणी में होंगे।
11. एएवाई परिवार को 35 किलो अनाज (25 किलो गेहूँ व 10 किलो चावल) उपलब्ध कराया जाएगा। प्राथमिकता श्रेणी परिवारों को 5 किलो अनाज (4 किलो गेहूँ व 1 किलो चावल) प्रति सदस्य प्रति माह मिलेगा।

Govt. of India has increased the central issue price of wheat and rice w.e.f. 1.6.97 and have further authorised the State Govt. to fix the price at FPS level. In view of this, Govt. of NCT of Delhi has after considering the requests from the Delhi State Civil Supplies Corporation and the Fair Price Shop Associations, revised the transportation charges and handling charges payable to D.S.C.S.C. and the margin of profit of the Fair Price Shop holders.

The revised prices of wheat and rice effective from 1.6.97 are as under:-

	Central Issue Price for FPS holders	Retail price for Card Holders.
Wheat	Rs. 450/- per quintal	Rs. 5.00 per kg.
Superfine Rice	Rs. 750/- per quintal	Rs. 8.00 per kg.

3. The transportation charges and handling charges payable to D.S.C.S.C. and margin of profit of the FPS holders have been uniformly fixed for wheat and rice as under:-

Handling & transportation	Rs. 15.00 per quintal
Margin of profit of Fair Price Shop holders	Rs. 35.00 per quintal

Higher increase in the margin of profit for wheat will automatically take care of the lower margin of profit for rice.

4. The drafts for wheat and rice for the 1st fortnight of June 97 and onwards will be prepared at the above central issue prices.

5. Unlifted stock of wheat and rice from the godowns of FCI as on 1.06.97 will be released by the FCI after taking additional drafts for the difference in the price which are Rs.48/- per quintal in respect of wheat and Rs. 102/- in respect of superfine rice.

6. If excess quantity of wheat is received in June against the May quota it will be adjusted in the month of June by reducing the equivalent quantity of wheat by the circle office at the time of next allocation.

7. Similarly the difference in the old and revised prices of wheat and rice at the above rates, on the stocks lying with the FPS as opening balance on 1.06.97 is to be paid to FCI.

8. Circle FSOs, through the Area Inspectors will note down these figures on 31.5.97 evening and obtain a declaration from each FPS in annexure-I (Enclosed). He will ensure that the FPS holders deposit the draft for the requisite amount with the Circle Office upto 6.6.97.

9. Entitlement for issue to the card holders has been further revised as under in view of the substantial reduction in
