Sir.

The undersigned along with Shri Suraj Parkash, Chief Advisor of our Delhi Sarkari Ration Dealers Sangh (DSRDS) had visited "SHRI KRISHAN GAUSHALA" on 8<sup>th</sup> November,2014 as a part of social work of the DSRDS, Delhi & spent sufficient time in going round the entire complex spread over 37 and a half acres of land. This GAUSHALA is located on land that was allotted by the Delhi Government in the year 1994. Its operations were inaugurated by late Sahib Singh Verma the then Development Minister of Delhi on 15<sup>th</sup> August, 1995. It is managed by a registered Trust namely "SURBHI SHODH SANSTHAN", which was registered under the SOCIETIES REGISTRATION ACT OF 1860 and was issued certificate of registration No.S-31507 of 1997 by the Registrar of Societies, Govt. of Delhi, Delhi.

There are about 6,500 number of cows at present, though when it was started there were only 13 cows in the year October,1994 and the GAUSHALA was founded by one Shri Chhagan Lal Gupta.

The purpose of above background is just informative.

Sir, there are 224 heads comprising labour & staff, who are residing within the complex in small hutments made by the trust as there dwelling units. All the labourers are illiterate. The total strength of all put together with their family members is 450 approx.

That none of the labour or staff living there have got their election cards issued by your office or the office of District Electoral Officer in charge of Kanjhawla constituency under whose jurisdiction it falls. Therefore it is very essential that all the labourers and staff who are eligible to cast votes are issued their voter identity cards. This is all the more important as the elections for the Assembly of Delhi are to take place very soon by early next year.

We are making this request on behalf of the trust and the founder member who assigned this duty to us.

We felt this as a part of our moral duty to bring to your kind notice and also humbly request your honor to intervene in the matter and preferably order for opening of a Temporary Desk in the office of the GAUSHALA for a period of two-three days for which the necessary facilities of tables and chairs for the deputed officers/staff shall be arranged. The office staff of the GAUSHALA will render necessary assistance of bringing the labour/staff for the purposes of filing required application forms for issuance of the voter cards of all illiterate but eligible citizens. We will also render due assistance for this noble task.
