The undersigned along with Shri Suraj Parkash, President ,Public Welfare & Common Causes Bureau, Delhi and now also Chief Advisor of our Delhi Sarkari Ration Dealers Sangh had visited **"SHRI KRISHAN GAUSHALA"** on 8th November,2014 as a part of social welfare activities of the PW&CCB as well as DSRDS, Delhi & spent sufficient time in going round the entire GAUSHALA complex spread over 37 and a half acres of land. This GAUSHALA is located on land that was allotted by the Delhi Government in the year 1994.Its operations were inaugurated by late Sahib Singh Verma, the then Development Minister of Delhi on 15th August,1995. It is managed by a registered Trust namely **"SURBHI SHODH SANSTHAN"**, which was registered under the SOCIETIES REGISTRATION ACT OF 1860 and was issued certificate of registration vide No.S-31507 of 1997 on 1st July,1997 by the Registrar of Societies, Govt. of Delhi, Delhi.

2. There are about 6,500 number of cows of different age group at present, though when it was started there were only 13 cows in the year October,1994 and the GAUSHALA was founded by one public spirited person Shri Chhagan Lal Gupta.

The purpose of above background is just informative.

3. Sir, there are 224 heads comprising labour & staff ,who are permanently residing within the GAUSHALA complex in small hutments made by the trust as there dwelling units. All the labourers are illiterate. The total strength of all the inhabitants put together with their family members is 450 approx.

4. That none of the labour or staff living there have got their ration cards issued by your office or the office of Assistant Commissioner[North West],Shalimar Bagh in charge of Kanjhawala constituency under whose jurisdiction it falls. Therefore it is very essential that all the labourers and staff who are eligible to subsidized ration are issued their ration cards. This request we are making on behalf of the **SHRI KRISHAN GAUSHALA** as per our discussions with the founder of the GAUSHALA and the Manager.

5. We felt this as a part of our moral duty to bring to your kind notice and also humbly request your honor to intervene in the matter and preferably order directing A.C[North West] for opening of a temporary desk in the office of the GAUSHALA for a period of two-three days for which the necessary facilities of tables and chairs for the deputed officers/staff shall be arranged. The office staff of the GAUSHALA will render necessary assistance of bringing the labour/staff for the purposes of filing required application forms with photographs etc. for issuance of their ration cards of all illiterate but eligible citizens. In case the F.S.I. working under the control of Assistant Commissioner[North West] is deputed to the SHRI KRISHAN GAUSHALA, we hope the exercise can also be completed in a few days by on the spot verification of their credentials with documentary evidence. As normally none of the male or female members move out of the GAUSHALA they were not even aware of their legitimate rights. They all belong to below poverty line families,[B.P.L. category] details about their monthly/annual income will be provided by the trust of the GAUSHALA, who maintain complete records. We will also render due assistance for this noble task, we wish to be done under your kind hands.

6. Sir, the undersigned would sincerely urge and wish your personal visit to the GAUSHALA on any day and time convenient to you so that you can also realize the predicament of the poor & needy inhabitants living there. **SHRI KRISHAN GAUSHALA** will extend warm welcome to your honour and feel extremely grateful & obliged.

7. Your blessings to the cause of these poor will go a long way in their life, for this act of **BENOVELANCE** or **PAROPKAR** you will shower on them they will cherish your memories in life.
