Subject:- Your orders sought for improving economic viability of the FPSs of entire Delhi by controlling/stoppage of short supply of SFAs & unwarranted warner charges/bakshish/jhunga demanded/charged by the labourers/drivers of Transport Contractors of DSCSC Ltd while unloading SFAs at the doorsteps/premises of the FPSs.

Respected Sir,

We are indeed grateful for your very active & dynamic approach we are seeing ,of late, in improving the operations & working of the public distribution system in Delhi. Introduction of Citizen's Corner covering e-portal, whatsapp, online registration of ration cards, Face Book, SFAs delivery messages on mobiles, etc. are a few to cite.

Further In this context we sincerely hope that in case your good self considers two three serious problems we are facing particularly through the DSCSC Ltd ,it will go a long way in improving the economic viability of each of the FPSs & they will forever remember & cherish your dynamism leadership. In brief the problems are :

As per the observations made from the official website of F&S Department of Delhi, above 3lac Qtls. Of SFA's (Wheat/Rice/Sugar) is supplied to about 2400 FPSs in Delhi through DSCSC Ltd. for distribution through us. You will be surprised that each FPS has to pay perforce @Rs 5/- to Rs 10/- Per Qtl. to the labourers/drivers of the T.C. (Transportation Contractors) of DSCSC Ltd. at the time of unloading of SFA's at the doorstep of FPSs as warner charges (BAKSHIS/JHUNGA) unofficially ,thus about Rs15 Lac to Rs30 Lac has to be paid by all the FPSs of Delhi put together every month. This is a sheer loss to the entire fraternity of shopkeepers.



Even due to short supply many poor NFS card holders are deprived from their legitimate Ration every month but never any action is taken by the In charge of concerned godown/depot of FCI or higher officers of DSCSC Ltd. We have mentioned and pointed out this many times about short supply of SFA's or poor quality of SFA's supplied or sample not received or misbehavior by the labourers /drivers of T.Cs. However, just to apprise your good self that these issues were raised by us in the periodical meeting of DSRDS headed by Shri U.K.Tyagi, Special Commissioner along with Sr.G.M-DSCSC Ltd. Sh Ajay Kumar Gupta & other higher officers of F&S department on 24th September 2014 at Hqrs of F&S department. But all in vain as no response we have got from Mr. Gupta though he promised in the meeting about short supply of SFA's, in future, FPSs will get SFA's only instead of seeking claim/refund from DSCSC Ltd. In this regard DSRDS requests for your direct intervention and orders & prays you to issue strict directions to all concerned officers to please cooperate us so that we can serve much better our service to poor people of NFS card holders/beneficiaries of Delhi in larger public interests. Sir, your-self being the head of both the organizations it is only you can help us in resolving this chronic menace, and improve our economic viability in running the FPSs.
