दिनांक 4 मार्च, 2015 के पृष्ठ नं.2, दिल्ली हिन्दुस्तान में प्रकाशित ''उचित दर दुकानो की रिक्ति के लिए अधिसूचना'' के संदर्भ में मौजुदा कार्यरत उचित दर दुकानदारों एवं अधिसूचना के माध्यम से आगुन्तक सफल आवेदको के हितो की रक्षा को लेकर में कुछ विशेष महत्वपूर्ण बिन्दुओं पर आपका ध्यान आकर्षित करना चाहता हूं। जो कि भविष्य में इन रिक्तियों की पार्दर्शिता और उचित दर दुकानदारों के साथ-साथ राशन उपभोक्ताओं के हितो को भी ध्यान में रखने हेत् आपके संज्ञान में लाना अति आवश्यक है।

(1) यह है कि जैसा कि आप भिल-भांति जानते हैं कि आपकी अध्यक्षता में दिनांक 6 मई 2014 को की गई कार्यवाही (Minutes) के पत्रांक संख्या F2(100)/F&S/COMP/2013-14/Pt. File/342

शैप सृचना अधिकारी : राहुल अग्रवाल - 9871420213

दिनांक 09.05.2014 में वर्णित पैरा नं. 6 के अनुसार यह सपष्ट है कि दिल्ली में कुछ राशन दुकानदारों के पास 500 से कम राशन कार्ड दर्ज हैं। और कुछ राशन दुकानदारों के पास 3000 हजार से ज्यादा राशन कार्ड दर्ज हैं तथा सभी सहायक आयुक्तों को निर्देशित भी किया गया कि राशन कार्डों की संख्या को दिल्ली की समस्त दुकानों पर एक समान संख्या में करने के लिए हर सम्भव प्रयास किये जाने चाहिए। परन्तु आज तक आपके इन आदेशों के पालन के प्रति किसी भी सहायक आयुक्त द्वारा कोई भी सकारात्मक या ठोस प्रक्रिया नहीं अपनाई गई है। और यह आदेश / निर्देश सिर्फ फाइलों में ही वर्णित रह गया। इस संदर्भ में उल्लेखनीय है कि खाद्य एवं सम्भरण विभाग द्वारा वैबसाइट पर उपलब्ध जानकारी के अनुसार दिल्ली में लगभग 16,70,000 राष्ट्रीय खाद्य सुरक्षा (NFS) उपभोक्ता है। इन उपभोक्ताओं के लगभग 60,00,000 लाख NFS सदस्यों के लिए 2411 उचित दर दुकानदारों द्वारा राशन वितरित किया जात है।

इस प्रकार अगर विभाग 16,70,000 राशन कार्डो को एक समान संख्या में प्रत्येक उचित दर दुकान पर लगाता है तो प्रत्येक दुकान पर लगभग 700 राशन कार्ड ही दर्ज हो पायेगे।

जबिक अतिरिक्त आयुक्त (P & C) श्री अजय कुमार गुप्ता के पत्रांक संख्या No. F.3(40)/2013/F&S/P&C/NFSA/Part File -IX/536-544 dt. 21.05.2014 के अनुसार मौजुदा सभी उचित दर दुकानों पर 1200 राशन कार्डो तक होने का इशारा करता है। जब तक प्रत्येक उचित दर दुकान पर यह संख्या बराबर या 1200 तक नहीं हो जाती, तब तक उचित दर दुकानों के लिए रिक्तियों की अधिसूचना जारी करना मौजूदा उचित दर दुकानों के साथ घौर अन्याय है और हमारी आय पर कुठाराघात है। परन्तु स्थित आज भी ज्यों की त्यों है। जिससे कम संख्या वाले उचित दर दुकानर को आर्थिक दुर्दशा का सामना करना पड़ रहा है।

(2) विडम्बना यह है कि आपके द्वारा जारी की गई अधिसूचना में आपने मण्डल सख्या/उचित दर दुकानों की रिक्तियों की संख्या/श्रेणी/कवर किए जाने वाला संबंधित क्षेत्र तो दर्शाया है परन्तु इन प्रस्तावित दुकानों को मिलने वाले राशन कार्डों की संख्या/राशन कार्डों पर मिलने वाली राशन सामग्री की मात्रा के साथ-साथ

Ad Memoire

Regarding the meeting held in the conference room of the Hon,ble Minister of Food & Supplies, Shri Asim Ahmed Khan ,GONCT Of Delhi at New Secretariat, Near I.T.O, New Delhi yesterday the 8th April,2015 at 02.30 p.m.

Inter alia the following issues were discussed thread bare and are listed below for the sake of record.

1. JUSTIFICATION FOR INCREASE IN MARGIN MONEY

At the outset representatives of the DSRDS informed that the increase done by the GONCT Of DELHI, DEPARTMENT OF F&S from Rs35/-P.Q[fixed in May,1997] to Rs70/- P.Q. w.e.f.1st September, 2014 is not at all acceptable. This does not help F.P.Ss even to meet their expenses in running of the shops.

A detailed analysis of the monthly earnings attempted by the DSRDS based on the official data of allocations of wheat and rice for the month of April,2015 was circulated amongst all the officers of the department for their perusal.[copy enclosed]

According to this just 2% of the 2323 total number of F.P.Ss in entire Delhi earn Rs21,000/- and above, whereas 98% of the F.P.Ss earn less than this. There are 241 F.P.Ss who earn only Rs3,500/- P.M. on the basis of Rs70/- P.Q. increased margin money.

As against this the monthly expenses incurred are around Rs33,000/-for every shop.

Shri Amar Nath Talwade, Special Commissioner responded stating that the department is fully convinced that even the revised rate of Rs70/- P.Q. is not adequate and they are equally concerned on this issue and are seized of the matter to see for the economic viability of the shops. Shri Deepak Virmani, Secretary to the MINISTER,F&S after hearing all present advised that soon some concrete and positive action will be taken.

2. PAY MARGIN MONEY FROM THE DATE SERVICES TAKEN

As regards increase already effected w.e.f. 1st September,2014 and not w.e.f.1st September,2013 when under the N.F.S.Act,2013 the services of the F.P.Ss were taken the officers present were all convinced and the Secretary to the M[F&S] agreed for this justification and assured proper action by the government.

3. RATIONALISATION OF NUMBER OF RATION CARDS TO BE TAGGED WITH EACH F.P.S.TO ENABLE EQUTABLE EARNINGS P.M. FOR MAJORITY OF F.P.Ss

As an offshoot of the skewed character of monthly allocation of quantities of SFAs amongst the F.P.Ss it is very essential that the number of ration cards are rationally distributed.

The 98% of the F.P.Ss have less than 200-300 quintals of quantity allocation p.m. with earnings less than Rs21,000/-. This is the root cause of frustration amongst the shopkeepers. Attention of the officers on the circular instructions issued by Shri Ajay Kumar was drawn directing all A.Cs to complete this exercise within 15 days but no action whatsoever taken by anyone of them.

Shri Uday Vir Singh, A.C[Distribution] tried to explain stating actions have been taken by them as per reports in the headquarters and very soon further action will enable maximum number of shopkeepers will be brought to mid level of 200-300 quintals p.m. President, DSRDS Shri Shiv Kumar Garg cited about position of Circle-17 where no action was taken at all. A.C[D] and Shri Talwade explained the reasons of resignations and or cancellation of shops has been one of factors responsible and the department will try to rationalize further.

4. UNJUSTIFIED SUSPENSIONS FOLLOWED BY CANCELLATION OF F.P.Ss BY A.C[NE] AND INDULGENCE INTO CORRUPT PRACTICES BY A.C[NE]

The representatives of DSRDS vehement ally pointed out about the typical character of A.C[NE] who in collusion with some anti social elements has been demanding Rs50,000/- for not cancellations failing which he cancelled the authorizations/license of the F.P.Ss knowing fully well that they did not deposit the advance drafts for the month of February,2015 as they had not

received any peny towards margin money for the last 11[eleven] months and had exhausted their capital. They had even submitted their replies with full justifications. The irony is their drafts were accepted late and allocations were made by the department and SMS messages flashed by the department to the consumers directly to draw their rations from such cancelled shops. Department Officers present agreed to check up the position for corrective actions.

5. CABINET COMMITTEE ON ECONOMIC AFFAIRS DECISION REGARDING MARGIN MONEY AND POS[POINT OF SALE] COMMISSION

Representatives of the DSRDS pointed out about the decisions taken on 25th March,2015 by the Cabinet Committee on Economic Affairs chaired by Shri Narinder Modi, P.M. are far too inadequate i.e, Rs70/- and Rs0.17 paise for POS on use of sales device. These cannot make any F.P.Ss economically viable and GONCT OF DELHI has to seriously think for suitable upward revision. Shri Talwade stated their government is very serious about economic viability of every shop and are in a dialogue with some IT oriented concern for a package under which a device will be made available at each F.P.S and it will be directly linked with leading hospitals. Any patient in need residing near the shop can/will be using such device available at the F.P.S. and for every use Rs20/- will be credited to F.P.S and Rs10/- will go to the IT company with whom such package deal is being thought of by the department. To this novel scheme being thought of, it was pointed out by the representatives of the DSRDS that this will not at all help as there cannot be any guarantee as to its help for each and every shop e.g.in industrial area of Wazirpur where low income daily wage earners or poor reside they may not be availing the consultations with doctors of highly reputed hospitals whereas in areas like G.K or Vasant Vihar these may but there cannot be equitable earnings for all the F.P.Ss. So the department has to think afresh on this. Moreover the dust prone environs of handling bags of wheat and rice does not suit such sophisticated electronic devices.

Already earlier decisions for sale of other articles at the premises of F.P.Ss has not helped, with the exception of few who have sufficiently large shop areas, but majority of shopkeepers do not benefit.

6. INACTION/CALLOUS ATTITUDE OF THE DEPARTMENT ABOUT BOGUS RATION CARDS MADE IN TRANS-YAMUNA AREAS BY THE AREA INSPECTORS/FSOs/ACs

Representative of Circle-65 expressed his anger about the complaint he had lodged one year back with all the documentary evidence but no action was being taken by the department and bogus ration cards at select shops allowed to exploit for personal pecuniary gains. Shri Talwade expressed surprise and desired no blame game to be raised here and if he can be handed over such complaint papers he will be the first person to take strictest actions and remove the evil cited. He was handed over a copy of the complaint then and there.[copy enclosed]. It is hoped necessary corrective action will be taken immediately as assured.

7. NON PAYMENT OF MARGIN MONEY SINCE APRIL,2014 TILL DATE TO A LARGE NUMBER OF F.P.Ss

The President of DSRDS pointed out about grievance of the shopkeepers who have not received any amount of margin money for the last eleven months therefore they are/were not in a position to deposit advance drafts for which the A.Cs are issuing show cause notices or suspension or cancellation orders. It is totally unfair on the part of the department. Shri Uday Veer Singh, A.C[D] handed over two lists of 202 and 86 F.P.Ss in whose cases the amount has been remitted to the banks but for want of their RTGS details/numbers these may be pending. In the said lists even the payment details pertaining to F.P.S.No7435 of the President, Shri Shiv Kumar was not appearing and needs to checked up afresh as these lists donot appear uptodate/correct.

8. SUGGESTIONS SOUGHT BY SHRI A.N.TALWADE, SPECIAL COMMISSIONER FROM DSRDS REPRESENTATIVES AS TO HOW ECONOMIC VIABILTY CAN BE IMPROVED AS F.P.Ss ARE AN INTEGRAL PART OF P.D.S

SHRI TALWADE apprised all present that with the introduction of N.F.S.Act,2013 the monthly allocation of SFAs has gone down as a result the monthly earnings of shopkeepers has gone down and the department is very well aware and seriously concerned about it. One of the suggestion made by the President, DSRDS was that in case the services of the F.P.Ss are

to be taken for all the 30 days in a month they should be treated as employees of the department and paid salaries on par with government employees. Alternatively there working hours be restricted to half a day for maximum 15 days within which the entire quantity of SFAs can be comfortably be issued and the licensees can do some other jobs to earn/compensate. The working hours can be either in the first half or in the second half of the day. The department will examine this aspect as it was appreciable suggestion.
