In this regard for the ensuing /proposed periodical meeting I am to convey suggesting few Agenda points as are indicated here below for your kind information in advance.

1. MARGIN MONEY ENHANCEMENT REGARDING

Sir, this matter alone is very vital and has been pending since long and we request your serious attention for the survival of entire fraternity of F.P.Ss and the continued sustenance of P.D.S. in the Capital of India.

2. RENEWAL TENURE FOR AUTHORISATION

Sir, this has assumed great importance due to variety of malpractices and complaints in the field offices of the department and sufferings of the F.P.Ss.

3. RATIONALISATION OF RATION CARDS

That we have been requesting for this since long and the department even issued instructions last year to all the Zonal Assistant Commissioners and F.S.Os but no serious attempt is made by field offices resultantly many marginal cases of F.P.Ss are resorting to tender resignations surrendering authorizations.

4. SECURITY DEPOSIT

That it used to be just Rs500/- and was enhanced to Rs5,000/- about two years back. And again enhanced to Rs10,000/-. This is used as a handle to exploit the shopkeepers for their minor deficiencies by the field formations using it as a threat for personal pecuniary gains.

5. VARNER CHARGES/BAKSHISH UNOFFICIALLY DEMANDED BY LABOUR OF T.Cs OF DSCSC LTD.

Sir, at the time of unloading of SFAs at the door steps of F.P.Ss LABOUR HAS BEEN CHARGING Rs10/- per quintal as varner charges or bakshish.

6. SHORT SUPPLIES OF SFAs/PROBLEMS OF REFUNDS ETC

That the consumers suffer as F.P.Ss are not in a position to issue in case of short supplies on the one hand and F.P.Ss suffer for obtaining refunds from DSCSC LTD.

7. PERIODICAL MEETING

Sir, we will be ever grateful if such periodical meetings are held once a month at your convenience in the presence of the senior officers including Zonal A.Cs so that operational problems faced by us are resolved as early as possible.

8. MINUTES OF PERIODICAL MEETINGS

We request for circulation of minutes for necessary actions in a time bound manner keeping DSRDS, DELHI intimated.

9. ANY OTHER ON PERMISSION OF THE CHAIR

Sir, we look forward in the mutual interests and in the larger public interests to improve the rationing system operating in DELHI under your guidance.
