THE MINUTES THEREOF ON THE VARIOUS DECISIONS TAKEN. SIR, ON CERTAIN POINTS OUR SANGH/ASSOCIATION WAS DIRECTED TO SUBMIT ITS VIEWS WHICH ARE INDICATED AS FOLLOWS:-

1. **SHORT SUPPLY OF FOOD GRAINS:-**

SPECIFIC DETAILS OF FPS-WISE SHORT SUPPLY OF FOOD GRAINS ARE GIVEN IN THE ENCLOSED ANNEXURE NO.1

2. **SAMPLE OF WHEAT TAKEN BY FASSAI FROM FPSs:-** DSRDS HAS ALREADY SUBMITTED ITS DETAILED REPRESENTATION TO THE C[F&S] BUT IN R/O DSCSC LTD WE HEREBY REQUEST YOUR GOOD SELF TO ORDER FOR THE NOMINATION OF THE NODAL OFFICER FROM YOUR HEADQUARTERS WHO SHOULD COORDINATE WITH THE FASSAI OFFICERS AND DEPUTE FROM DSCSC LTD ONE OF ITS OFFICERS TO THE FPSs WHEREVER FASSAI /FOOD SAFETY OFFICERS WISH TO CONDUCT ITS INSPECTION OF WHEAT AND OR RICE. THIS WILL GO A LONG WAY IN PROPER INSPECTION AND ALSO DSCSC LTD OFFICER DEPUTED TO COLLECT ONE SAMPLE AND ALSO THE FASSAI OFFICERS TO LEAVE ONE SAMPLE WITH THE FPS CONCERNED FOR REFERENCE .

3. **SAMPLE OF WHEAT AND RICE TO ALL FPSs :-** IT HAS BEEN OUR BITTER EXPERIENCE THAT DESPITE REPEATED REQUESTS SAMPLES OF EITHER WHEAT OR RICE AND SUGAR ARE NOT REPEAT NOT GIVEN FOR EACH OF THE FPSs AT ALL. EVEN FPSs HAVE BEEN GIVING IN WRITING AT THE TIME OF GIVING ACKNOWLEDGEMENT THIS AS A PART OF THEIR COMPLAINT TO THE TRANSPORTER [T.C] OF THE DSCSC LTD.



IN FACT IF DSCSC LTD PLACES SOME KIND OF PENALTY ON THE T.C. OF THE DSCSC LTD IT WILL BRING SOME RESPONSIBILITY ON THE T.C. WHO WILL ENSURE THAT SAMPLES ARE GIVEN FOR EACH AND EVERY FPSs.

4. **WEIGHMENT OF SMALL QUANTITY AT FPSs:-** YOUR GOOD SELF WOULD APPRECIATE THAT THE T.C. OF THE DSCSC LTD SHOULD INVARIABLY GET THE SMALL QUANTITY OF SFAs UPTO 25 QUINTALS WEIGHED AT THE FPS ITSELF THROUGH THEIR ELECTRONIC WEIGHING SCALES/MACHINES AT THE TIME OF GIVING DELIVERY OF SFAs AT THE FPS CONCERNED.

5. **PAYMENT BY FPS HOLDER TO THE LABOUR OF TRANSPORTER:-** THIS MENACE HAS BEEN CONTINUING UNABATED DESPITE YOUR PREDECESSOR C[F&S] SHRI S.S.YADAV HAD ON 24 FEBRUARY,2015 GOT RELEVANT INSTRUCTIONS ISSUED MEANT FOR ALL THE T.Cs OF DSCSC LTD FOR GIVING DELIVERY OF SFAs AT THE FPS LEVEL VIDE REFERENCE NO.F.15(210)/10/PDS HQ/1860 DATED 24-02-2015 AS PER CLAUSE 10(d) QUOTED BELOW:-

**“10(d) THE CONTRACTOR SHALL BE RESPONSIBLE FOR STACKING OF BAGS AT THE FPS VERTICALLY WITHOUT ANY EXTRA CHARGES”.**

OUR DSRDS REQUESTS YOUR GOODSELF TO GET THIS ENFORCED THROUGH THE T.Cs.IT WILL BE BETTER IN CASE 90% OF THE HEIGHT OF EACH & EVERY FPS'S PREMISES GETS COVERED BY PROPER STACKING.

YOUR GOOD SELF WOULD APPRECIATE TO KNOW THAT OF THE TOTAL MONTHLY ALLOCATION OF WHEAT/RICE & SUGAR OF APPROX 3.90 LAKH QUINTALS ALL THE FPSs ARE

SHEDDING ALMOST Rs35/- TO Rs40/- LAKHS PER MONTH @ Rs10/- PER QUINTAL AT THE TIME OF UNLOADING OF THE SFAs, WHICH IS NOTHING BUT TOTALLY AVOIDABLE EXPENSE PAID TO THE LABOURERS UN-AUTHORISEDLY IN THE FORM OF VARNER CHARGES [BAKSHIS] FOR PROPER UNLOADING & STACKING OF THE SFAs AT THE FPS PREMISES. YOUR INTERVENTION ONLY CAN HELP THE ENTIRE FRATERNITY OF THE FPSs.

**ADDITIONAL POINTS:-**

**1. SUPPLIES OF WHEAT/RICE IN PARTS:-** IT HAS BEEN OBSERVED THAT ON MANY A OCCASIONS THE T.Cs BRING THE SFAs MEANT FOR THE FPS IN SMALL PARTS ON MORE THAN TWO-THREE OCCASIONS. INSTEAD OF BRINGING ENTIRE QUANTITY IN ONE GO. THIS HAS BEEN CREATING A LOT OF PROBLEMS AND YOUR INTERVENTION IS SOUGHT BY DSRDS.

**2. MENACE OF DIVERSIONS:-** SIR, AS A PART OF GENERATING PRESSURE ON THOSE FPSs WHO DONOT WISH TO PAY ANYTHING TO THE T.Cs OF THE DSCSC LTD OR DONOT WISH TO ALLOW ANY KIND OF DIVERSIONS OF WHEAT TO THE ROLLER FLOUR MILLS THE T.Cs ARE ABLE TO MANAGE & BRING THE ENTIRE STOCKS OF SFAs OF THOSE FPSs EVEN OUT OF TURN IN LEAGUE WITH THE FCI/DSCSCLTD STAFF POSTED IN THE GODOWNS. IN FACT NO SYSTEM IS FOLLOWED AS A RESULT THIS MALPRACTICE IS EXPOILTED BY THE T.Cs. DSRDS THEREFORE REQUESTS THAT PRIORITY BE GIVEN FOR THOSE FPSs WHOSE QUANTITY INVOLVED IS THE LEAST ONE AND SO ON.

IN VIEW OF THE ABOVE YOUR GOOD SELF IS REQUESTED TO KINDLY TAKE NECESSARY APPROPRIATE ACTIONS & ISSUE NECESSARY DIRECTIONS IN ORDER TO STEAMLINER THE SYSTEM OF PDS IN DELHI.
