A-propos discussions on late in your chamber I am to inform that I have received three complaints of FPS whose authorization/license have been cancelled by worthy AC(N) in respect of


- M/s Pratap Singh Rakesh Kumar FPS No. 601/C-16

Just prior to 21.03.2018 when the department issued orders dispensing with condition that was stipulated in July 2015 Policy Issued by the department and applicability in fresh cases only. The cancellation letter have been issued in the first week/third week of March 2018 by AC(N). Appeals have been already referred by all the three FPSs.

Sir, AC(N) is also imposing a penalty of Rs. 100/- per day which is not justified and be advised not to do so on poor licenses.
