IT IS A MATTER OF VERY SERIOUS NATURE THAT THE ENTIRE DELHI IS FACING TODAY DUE TO THE UTTER FAILURE OF BOTH THE INSTITUTIONS RESPONSIBLE OR SMOOTH MAINTENANCE OF THE PUBLIC DISTRIBUTION SYSTEM IN ORGANISING THE SUPPLIES OF ESSENTIAL COMMODITIES MEANT FOR DISTRIBUTION BY THE F.P.Ss TO THE POOR RATION CARD HOLDERS. THIS, AS WE HAVE COME TO KNOW, HAS BEEN DUE TO NON APPOINTMENT OF TRANSPORT CONTRACTORS[T.Cs] TIMELY BY THE

DSCSC LTD EXCEPT FOR NARELA GODOWN OF FCI, THAT TOO PARTLY. AS A RESULT THE SUPPLY LINE HAS BEEN TOTALLY CLOSED.

- 2. YOUR HONOUR MAY BE AWARE THAT AS PER RULES THE RESPONSIBILTY OF ARRANGING THE SUPPLY OF SFAS AT THE DOOR STEP OF F.P.Ss LIES WITH THE DSCSC LTD. THIS ARRANGEMENT HAS BEEN GOING ON TRADITIONALLY & SYSTEMETICALLY FOR SEVERAL YEARS ON BEHALF OF THE DEPARTMENT OF F&S, THOUGH IT HAD ITS OWN PITFALLS OF ILLEGAL DEMAND BY THE HANDLING LABOUR OF T.Cs CHARGING VARNER CHARGES FROM THE F.P.Ss FOR EVERY QUINTAL OF FOOD GRAINS HANDLED.THIS WAS BEING TOLERATED BY THE F.P.Ss WITH GREAT ANGUISH FOR ALL THESE DAYS EVEN THOUGH RAISED BY US SEVERAL TIMES.

NOW THE RESPONSIBILTY OF TRANSPORTATION OF FOOD GRAINS IS BEING SHIFTED UPON THE F.P.Ss FOR DIRECTLY LIFTING / COLLECTING S.F.As AGAINST THE ALLOCATIONS FOR THE MONTH OF JUNE, 2014 FROM SHAKTI NAGAR/MAYAPURI GODOWNS FOR DISTRIBUTION TO PUBLIC.INTERESTINGLY IN THIS REGARD F.S.O, CIRCLE-17 WAZIRPUR HAS ISSUED AN OFFICE ORDER NO.:-FSO/CIRCLE-17/39-82 DATED 11/06/2014 AND ISSUED TO ALL THE F.P.Ss CITING DIRECTIONS OF THE ASSISTANT COMMISSIONER[NORTH]. COPY OF THE SAID OFFICE ORDER IS ENCLOSED HEREWITH FOR READY REFERENCE. YOU WILL KINDLY APPRECIATE HARD FACT WHEN DSCSC LTD. HAS FAILED TO POSITION TCs BY APPOINTING THEM THEN HOW INDIVIDUAL FPSS WOULD BE ABLE TO ARRANGE TRANSPORERS? HOW IS IT GOING TO BE PRACTICALLY FEASIBLE?
- 4. AS A CONSEQUENCE THERE IS GOING TO BE DUAL SYSTEM OF TRANSPORTATION OF FOOD GRAINS IN DELHI VIZ, IN THE CASE OF SOME PARTS OF DELHI SIX GROUPS OUT OF NINE GROUPS, TRANSPORT CONTRACTORS TAGGED WITH NARELA GODOWN OF FCI WOULD CONTINUE TO SUPPLY THROUGH DSCSC LTD AT THE DOOR STEPS OF F.P.SS, WHEREAS FOR THE REST OF DELHI THE F.P.SS ARE BEING FORCED TO MAKE THERE OWN ARRANGEMENTS OF TRANSPORTATION TO LIFT DIRECTLY FROM THE DEPOTS OF FCI.THERE IS NO DISCLOSURE OF ANY TERMS & CONDITIONS OR THE RATES REIMBURSABLE TO THE F.P.SS AND ABOVE ALL ,ALL THE F.P.SS HAVE ALREADY DEPOSITED THE COST OF TRANSPORTATION CHARGES FOR A.P.L CATEGORY OF QUANTITY OF FOOD GRAINS @ RS 60/- PER QUINTAL WITH DSCSC LTD ALONGWITH COST OF FOOD GRAINS. KNOWING THIS FACT, IT IS SURPRISING HOW THE F.S.O-CIRCLE-17/ASSISTANT COMMISSIONER [NORTH] HAVE ISSUED THE AFOREMENTIONED OFFICE ORDER. THIS IS AN ILLEGAL ACT ON THE PART OF THE DEPARTMENT, YOUR HONOUR WILL APPRECIATE.
- 5. ABOVE FACTS WOULD REVEAL THAT THERE HAS BEEN LET LOOSE ARRANGEMENT WITH VARIETY OF SCOPE TO INDULGE INTO MALPRACTICES BY VESTED INTERESTS. IN ABSENCE OF ANY DEFINED GUIDELINES AND THERE IS IMPLIED ORAL CONSENT AND

AND THE MATTER IS SUBJUDICE BEFORE THE HIGH COURT OF DELHI AT NEW DELHI[CASE NO.W.P(C) NO1657/2014].IN ALL LIKELIHOOD ONCE AGAIN THE DEPARTMENT WANTS TO INVITE FRESH LITIGATION.
