Minutes of the meeting regarding issues of FPS owners held on 21/10/2016 at 4:00 PM in the conference hall chaired by the Commissioner, F&S.

The meeting was attended by many FPS owners, President and Secretaries of FPS owners associations. (List attached). The following issues were discussed and deliberated upon:-

1. Margin Money:- It was informed by the Association that margin money paid to FPS owner should be enhanced as it is not sufficient to meet out the expenses of the shop. The Commissioner, F&S advised them that if the association wants to take up the issue with Central Govt., they may do so at their won level.

Action on the part of the Association

2. Rationalisation of NFS Cards:- The FPS owners brought the issue of rationalisation of NFS cards. They pointed out that there is huge variation so far linkage of ration cards to the FPS is concerned. They desired that the rationalisation be done on priority, and the same should be done quantity wise and not card wise. The CFS directed all the Zonal ACs to submit the status report in the matter.

Action on the part of all the Zonal ACs

3. Transfer of Cards:- The association brought to the notice of the Chair that cards are not transferred from one FPS to another or from one circle to another as the concerned FSIs/FSOs take the plea that their IDs have been blocked. The CFS directed the System Analyst to look into the matter and sort out the issue.

Action on the part of IT Branch

4. Shortage admissible:- The association informed that shortage of half a kg per quintal was allowed in 1966. However, they informed that Dethi specified Articles (Regulation of Distribution) order, 1981 is silent on the issue. Further, National Food Security Act also does not throw any light on this issue. The CFS desired that the association should submit representation in this regard for further necessary action in the matter.

5. Weight of SFAs given in bags by FCI godowns:-The association informed that bills are issued for net weight by the FCI godowns. The weight of the jute bags etc. are also included in the net weight which is incorrect. The CFS desired that the matter be examined.
